The post holders will have considerable experience of supervising and managing therapists and practitioners in Children's Mental Health service. You will have an ability to work effectively within a team. You will demonstrate strong leadership skills and be an organised individual who can work creatively to develop and manage the day to day operation of the service.

Across the two posts the postholders will have varied duties including: managing and supervising practitioners, allocating caseloads, co-ordinating assessment processes, manage risk processes, audit cases, co-ordinate multi-disciplinary consultation meetings, coordinate group interventions. There are key opportunities to work strategically the partnership in Bromley as necessary. You will have skills in report writing, training and giving presentations.

The post holder will have a small caseload to maintain skills and accreditation with professional bodies. The post holder will work with people from various cultural backgrounds, ages and ability, using interpreters when necessary and should be committed to equity, diversity and inclusion.
